2.	 Cycle Count Rob had analysed the count data for the last three years. There was lots variation between the sites, but when all of the sites were considered as a 	

- whole, the following trends were observed:
 - June consistently had the highest number of observed cyclists followed by October, with February having the lowest.
 - The overall number of cyclists had grown by 10%, which was considered to be significant.

	 Male cyclists significantly outnumbered female cyclists. 	
	 Sites near schools had significant numbers of children / young people cycling. 	
	 There were just a couple of sites that had 'high' cycling flows, with most in the mid-range and Hungerford was at the bottom with very low flows. 	
	 It was noted that the Hungerford Neighbourhood Plan was out to public consultation. This was proposing a number of pedestrian / cycling routes, but several did not appear to be suitable for cycling. Spokes to draft a response. 	PR
	 It was suggested that the cycle count sites should be reviewed and new sites considered. Clive to discuss with WBC Transport Policy. 	СТ
	The prize draw was held for the February count – Ed Cooper was the winner.	
3.	Eling WayThe drainage design for Phase 1 of the southern extension was awaited.	
	 One landowner had indicated that they were not interested in formalising the existing permissive route across their land. 	
	 Currently, it was only possible to take the route as far as Yattendon Road. 	
	It was suggested that the Parish Council be asked to provide support.	
	 Options for subsequent phases were being considered by consultees and would be considered by the Active Travel Board on 13 March. 	
	 Clarity was needed as to whether the scheme would continue to be progressed by WBC or handed over to Sustrans. 	
	 William to push for commitment to the scheme at the Cycle Forum. 	WP
	It was noted that the existing route had suffered damage in a number of places near M4 and on the overbridge. WBC Public Rights of Way were aware. It was agreed that the need for maintenance of the existing route	
	should be flagged at the Cycle Forum.	WP
	 It was confirmed that the dropped kerb at Hampstead Norreys Village Hall had been approved by Village Hall Committee, and the scheme would be combined with some cycle parking. 	
5.	Cycle Schemes	
	 Clive provided an update: 	
	 Stockcross Path – line painting remained outstanding on Phase 1. A water leak was being fixed by Thames Water.

	 A4 / Crown Mead, Thatcham – Active Travel England had approved on-carriageway cycle lanes and a single stage toucan crossing. This would be constructed in the autumn. 	
	 Newbury Manor Hotel – This was with WBC Legal to arrange the land transfers. 	
	 Old Bath Road, Pangbourne to Purley – Schemes were in development. 	
	 Western Avenue Stage 2 – Options were being considered and it was hoped to secure buy-in from Project Board. 	
	 Active Travel 4 Scheme – Concepts were being worked up for Stockcross Stage 2 to Speen Lane. This would widen the southern footway. The existing bridge parapet was too low, so mitigation measures were needed. Also, Highways England agreement was needed. Spokes highlighted concerns about cyclists' safety at the roundabouts. 	
	 Theale to Calcot Bridge Replacement – A feasibility study had been completed. This would be very costly. However, it was hoped that the scheme could progress to outline design. 	
	 Wash Water Development – The developer had agreed to a 1.8km pedestrian / cycle route up Andover Road past Park House School. There would be challenges with the drainage swales. 	
6.	NCN4	
	 Greenham Trust had allocated £12K to Sustrans for Project Management of the NCN Upgrade within Newbury (Northcroft to the Football Club). This would address subsidence issues outside Camp Hopson Furniture Store. Funding for the works remained outstanding. 	
	 Engagement was ongoing with Greenham Trust regarding a much larger proposal for towpath upgrades over the longer-term. 	
	 Sustrans had been due to undertake improvements work in the vicinity of the Cunning Man PH at Burghfield, but had been forced off-site by the floods. Works were now expected to be completed by April. 	
	It was noted that there had been serious flooding east of Ham Bridge.	
	The Canal and River Trust had appointed a new Enterprise Manager.	
7.	Comms and Engagement	
	 William had provided some further articles for the website on the Spain trip.
